**OFFICE MEMORANDUM**

**Sub: Cashless medical facility for CSIR-IGIB employees, pensioners and their dependent family members.**

**Ref. : CSIR Hqrs, New Delhi OM No. 8-3(11)/2019-Gen. (Med.) dated 14.8.2019 (Copy overleaf).**

CSIR Hqrs., New Delhi vide OM referred to above has intimated that the following CGHS empanelled hospitals/institutes who have signed separate Memorandum of Agreements (MoAs) with CSIR Hqrs. have agreed to provide credit facility for indoor treatment to serving staff, pensioners and their dependant family members on CGHS approved / package rates to the Delhi based laboratories/institutes of CSIR :

The serving staff, pensioners and their dependant family members of Delhi based laboratories/institutes of CSIR may also now take indoor treatment on credit basis at the above mentioned hospitals/institutes.

Requests for extending credit facility have to be made by the individual so that Lab./Instt. can issue necessary authorization.

The hospitals / institutes concerned will submit their bills / reimbursement claims directly to the concerned laboratory / institute of CSIR and it will be ensured by the concerned laboratory/institute to clear the bills/reimbursement claims of the hospitals within the time frame as stipulated under MOAs signed by CSIR Hqrs.

Accordingly, serving employees and pensioners may give information and obtain necessary permission from CSIR-IGIB, in writing for obtaining indoor treatment in respect of self and their dependant family members, as and when required.
