- All bids must be accompanied with a Bid Security (BS/EMD) for an amount as specified above or Bid Securing Declaration as per format provided in the tender document. The bids shall be submitted online only, whereas the bid security (only If opted for EMD) in original shall be delivered to this office on or before the due date for submission of the bids.
- As per Govt. of India procurement policies:
 - The purchaser intends to give purchase preference to local suppliers* in case the cost of procurement is up to Rs. 50.00 lakhs.
 - There is no restriction on the eligibility of the suppliers.
 - The procuring entity intends to give purchase preference to products/goods manufactured by Micro & Small Enterprises (MSEs).

*" Local supplier" means a supplier or service provider whose product or service offered for procurement meets the minimum local content of 50% as prescribed in DIPP Order No. P- 45021/2/2017-PP (BE-II) dated 29th May, 2019 or by the competent Ministries/Departments in pursuance of this order.

'Local content' means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the items procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

The Director, CSIR-IGIB reserves the right to accept or reject any bids or accept all tenders either in part or in full or to split the order, or to annul the bidding process without assigning any reason.
